

# **Recognizing HWI Funding**

Congratulations on receiving a grant through the Healthy Watersheds Initiative. This is an exciting year for freshwater work, and we're looking forward to working with you and hearing about your team's progress in the months ahead.

These guidelines will help you recognize funding received through the Healthy Watersheds Initiative, which is delivered by the Real Estate Foundation of BC (REFBC) in partnership with the Province of British Columbia and Watersheds BC (WBC).

By acknowledging the Healthy Watersheds Initiative, project teams help to build awareness and support for public investments in watershed conservation and restoration work. Recognition statements also help audiences understand where this funding came from, how it's connected to the Province's Economic Recovery Plan, and what kinds of projects the Healthy Watersheds Initiative is supporting.

### **Recognizing Support**

We encourage project teams to acknowledge support from the Province of BC, REFBC, and WBC, through the Healthy Watersheds Initiative, in all public communication related to their projects, including online and on social media, at events, and in publications and promotional materials.

#### **Suggested Statement:**

"This project was supported through the Healthy Watersheds Initiative, which is delivered by the Real Estate Foundation of BC and Watersheds BC, with financial support from the Province of British Columbia as part of its \$10-billion COVID-19 response."

To acknowledge financial support, project teams may use the suggested statement in combination with the REFBC and WBC logos. For major announcements, project teams may also wish to use the Province of BC's logo.

The table below includes examples and suggestions for when and how to recognize support.

Context	Examples of ways to recognize support
Media releases and interviews	<ul> <li>Include the suggested statement in releases and announcements.</li> <li>Reference the Healthy Watersheds Initiative in boilerplate statements.</li> <li>If appropriate, request a quote from the Healthy Watersheds Initiative.</li> </ul>

Publications and promotional materials	<ul> <li>Include the suggested statement in publications and materials.</li> <li>Include the Healthy Watersheds Initiative logo and, if appropriate, REFBC and WBC's logos.</li> <li>Consider requesting permission to use the Province of BC's logo.</li> <li>Include boilerplate statements on the Healthy Watersheds Initiative and funding partners in an acknowledgments section.</li> </ul>
Websites and social media	<ul> <li>Include the suggested statement on project web pages.</li> <li>Include a link to <u>healthywatersheds.ca</u>.</li> <li>Include the Healthy Watersheds Initiative logo and, when appropriate, the REFBC and WBC logos.</li> <li>Tag the Healthy Watersheds Initiative (@healthywatersbc) in social media posts and use #HealthyWatersBC.</li> </ul>
Events	<ul> <li>Include the suggested statement on event invitations, programs.</li> <li>Acknowledge the Healthy Watersheds Initiative, REFBC, Watersheds BC, and the Province of BC in opening statements.</li> <li>Include the Healthy Watersheds Initiative logo on slides, visuals and, when appropriate, the REFBC and WBC logos as well.</li> <li>If appropriate, invite a representative from the Healthy Watersheds Initiative staff and advisory team to attend and/or speak at your event.</li> <li>If inviting an MLA, MP, or senior government official, provide advance notice to the Healthy Watersheds Initiative team and, if possible, request to use the Province of BC's logo.</li> </ul>

The examples above are intended as *suggestions*. While we ask that the Healthy Watersheds Initiative is recognized in some way in all public communication, project teams can choose the types of recognition that are the best fit for their audiences, communities, and communication formats.
